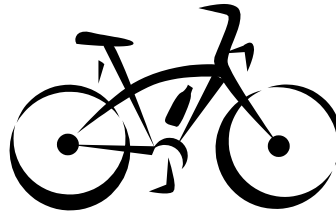

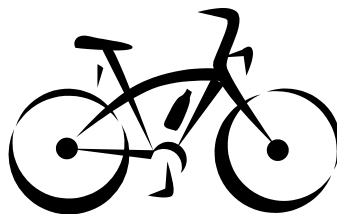

## Affirmation & Liability Release

I hereby personally assume all risks associated with my voluntary participation in this event for any harm, injury or damage that may befall me as a result of my participation, whether foreseen or unforeseen, including but not limited to falls from my bicycle or collisions involving my bicycle and another vehicle, other cyclists, or stationary object.

I understand and agree that neither Kiwanis International nor Hudson's Bay Key Club located in the city of Vancouver and state of Washington may be held liable in any way for any occurrence in connection with my participation in the Bay-to-Bay Bike Ride that may result in injury, death, or other damages to me or my family, heirs, or assigns and in consideration of being allowed to participate in this event, I hereby personally assume all risks in connection with said event for any harm, injury or damage that may befall me, including all risks connected therewith, whether foreseen or unforeseen and further to save and hold harmless said event and persons from any claim by me, or my family, estate, heirs, or assigns arising out of my participation in this event.

I further state that I am of lawful age and legally competent to sign this affirmation and release, or that I have acquired the written consent of my parents or guardians; that I understand the terms herein are contractual and not a mere recital; and that I have signed this document of my own free will.

It is my intention by this instrument to exempt and release Kiwanis International and Hudson's Bay Key Club from all liability whatsoever for personal injury, property damage or wrongful death arising out of or in the course of my participation in this event.
